# **Approval of Prior Meetings Minutes**

# **Manager's Report**

Property did well through Hurricane Irma. Phase 2 of the Main Clubhouse was officially completed just after the storm. We have received no responses from any engineers. Abe has returned to work from his absence due to an injury, he is doing well. Thank you to staff for their efforts to help prepare for the storm and helping to get the District up and running after the storm. Two proposals for work at Satellite 3 are included in the package. Attorney publication has been posted. We have received one proposal and one potential.

# **Treasurer's Report**

#### **Old Business**

The board discusses the proposals from attorneys. The board would like to hold interviews with the attorneys.

Consideration of bids received for concrete work at Satellite 3

**M3**: Steve Salkin motions to complete work and re-install one shuffleboard court. Bob Mendelow seconds. All vote yes except Stan Leibowitz. Motion passed.

Sandra Hankin points out that the proposal from Paragon homes includes a description of 7% sales tax and Broward County has 6% sales tax. The total proposal does not include sales tax. Asks to have bids revised for clarification to include 1 shuffleboard court.

Steve Salkin discusses an old business item relating to contingency funding.

**M4**: Steve Salkin motions to move funds previously marked as contingency funds to a capital funding line item. Sandra Hankin seconds. All I favor. Motion passed.

#### **New Business**

Update on Hurricane Irma: Some trees came down and some roof leaks showed up in the main clubhouse. Satellite 1 had a flashing repair. The pool at Satellite 5 is not working. An electrical line was down by Satellite 1, it caused lights on the canal road to go out.

M5: Jack Meehan motions to allow the City to haul away hurricane debris. Stan Leibowitz seconds. All in favor, motion passed.

M6: Steve Salkin motions to have the District stop supporting the monument/fountain on the North side of the Nob Hill entrance – to take effect 30 days from the date of this meeting (October 19). Sandra Hankin seconds.
